Resignations

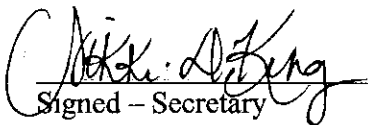

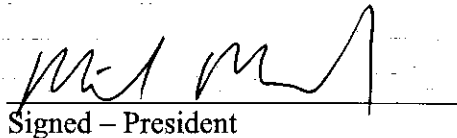
Hiring
